

### **Festive services reminder**

Kerbside recycling and refuse collections will take place as usual on Monday 24 December. Between Tuesday 25 December and Friday 28 December, all scheduled collections are two days later, including Friday pick-ups on Sunday 30 December.

Monday 31 December services follow their usual schedule but between Tuesday 1 January and Friday 4 January, all scheduled collections are one day later, including Friday collections on Saturday 5 January.

These revised dates include assisted and clinical waste collection services. Please ensure you have your recycling and waste ready for collections by 7am and no earlier than the night before.

All recycling sites will be closed on Christmas Day, Boxing Day and New Year's Day. On Christmas Eve and New Year's Eve all sites usually open until 7pm will be closing at 4pm. ### **Christmas trees**

You can either home compost your tree, take it to a recycling site or, if you have a garden waste subscription, bare trees under 6ft can go out for collection on your usual garden waste collection day from 7 January. Also look out for local charity shredding /collections. As a very

last resort, trees can be sent to costly, wasteful, polluting landfill. Place it next to your rubbish bin on your usual collection day (7-18 January 2019 only).

### **Can you recycle festive wrap?**

Did you know that not all gift-wrap can be recycled after the big day? A lot of wrap is either low quality paper containing few good quality fibres or is a plastic laminate i.e. foil-backed. Some wrap is "contaminated" by plastic glitter, or, is so covered in sticky tape that it cannot be recycled.

Before recycling your wrap, scrunch it to check it is paper – if it springs back it is plastic and should be put in your refuse. If paper, remove sticky tape and decorations and recycle with cardboard.

### **Winter weather reminder**

### **How paper is recycled**

In Somerset 99% of the paper we collect stays in the UK. The largest paper mill we use is run by UPM in Deeside, North Wales. During 2017-18

we sent them 6179 tonnes of paper collected from kerbside collections. They accept a wide range of used paper including leaflets, newspapers, magazines, directories, white envelopes and white printer paper.

All newspaper and magazines received by UPM are reprocessed into newsprint made of 100% recycled paper. For our paper to be in demand by UK mills it needs to be of high quality and not contaminated by other materials. Even cardboard contaminates the paper making process, which is why we ask that paper and cardboard is not mixed for kerbside recycling pick-ups.

The recycled paper we send them is turned into clean white pulp of individual fibres and all the ink and other residues are removed. New newsprint is created by an enormous machine which allows the pulp to progressively be turned into a continuous sheet of paper moving at up to 60mph. At the end of the machine, the paper is wound on to jumbo rolls 8 metres wide which hold approximately 30 tonnes of paper.
