

# Minutes of the meeting of the Parish Council held in Ashill Village Hall on Monday 1<sup>st</sup> September 2025 at 7.30 pm

#### 38/25 Chairmans' Opening Statement

The Chairman welcomed everyone to the meeting.

# 39/25 Public Participation

Several members of the public wished to speak about the speed of vehicles on Wood Road. Key points were:

- o The sign at Hastings was still missing.
- The surface of Thickthorn Lane had deteriorated significantly and cars had been seen to ground out on the bumps.
- The speed, general awareness of drivers and manner that vehicles are driven on Wood Road had got worse.
- There was a dip in Wood Road, near Thickthorn Lane which was dangerous if hit at speed.
- There had been a recent accident on Wood Road. The police had not been interested as nobody had been hurt.
- Could speeding data be collected for Wood Road? The Parish Council would have to finance this as Somerset Council would not.
- Village gateways were popular along with asking residents to mow verges and cut hedges to make the area look more domestic.
- The school bus dropped children off on Wood Road, near the Flying Fish pub.
   There were no pavements or signs here would it be possible?
- One resident had spoken to delivery drivers along Windmill Hill who admit that their times are unachievable so they have to travel at the maximum allowed speed on a road to reach their targets.
- There is potentially a development of 120 houses being planned in Horton Parish and there was concern that Ashill would become a cut through to the A358, if this went ahead, which would make slowing traffic through the village important.
- There is a sign on Windmill Hill which classed the road as unsuitable for vehicles above 7.5mt, but it is not easily seen. The parish of Bickenhall have a blue sign which would be more visible.

A member of the public reported that a large gate post, on the footpath on Windmill Hill Lane was wobbly and the handrail was fixed to the post. This would be investigated.

A member of the public noted that the dog bins had been in place 4/5 years. Prior to the bins being installed bagged feces was hung in hedges and there was a concern that if the dog bins were removed, dog walkers would not pick up after their dogs.

Unitary Councilor Osborne reported:

• There was a temporary change to the Planning Department, and Planning Officers could no longer be contacted on a direct line. There was a generic email address that should be used. This was being done to try to reduce the waiting list of

- planning applications. There would also be no site visits and simplified conditions, which could be to the detriment of the local community.
- Budget: Q1 showed an overspend. A new Section 151 Officer had started last month and in order to set the budget for 26/27 Somerset Council would need to save over one hundred million pounds. Finances were still very fragile.
- Somerset Council had used capitalization directives for the last couple of years to meet budgets and they may have to do the same again. The capitalization directive allowed a council to sell assets to cover day to day running costs. Central Government must authorize this.
- Somerset Council were keen to devolve assets and services to parishes but there
  was a backlog.
- Drainage, safety defects and potholes were still Somerset Council's responsibility.
- There had been a change of Highways Officer for this area.

#### 45/25 Playing Field

a) To receive an inspection report for the playing field.

Cllr Fry thanked the volunteers that helped to cut the playing field hedges. Rabbits were still a problem on the playing field and Cllr. Fry was investigating solutions. A volunteer had offered to fill the rabbit holes in the autumn and a dumpy bag of top soil should be purchased to go up there for him. Sonar could be purchased for £50 but it couldn't be fixed to the ground and it was possible for young children to hear them too. As the playing field was for small children this may not be a suitable option. Cllr. Fry would investigate an exterminator to manage the rabbit population.

There was a report from an anonymous person regarding the skate park. There was a gap at the bottom of the ramp between the metal and the tarmac. It was felt that the easiest option was to fill the gaps and a working party would be organized to move the metal slightly to reduce the gap.

There had been much discussion regarding this subject during public participation. The Parish Council AGREED to pursue Village Gateways and the Chairman would make contact with the Highways Engineer. A small working group would be put together to identify suitable areas for gateways.
