1/22 Appointment of Chairman

It was proposed & seconded for Cllr Varney to be the Parish Council Chairman for the 2022/23 council year & it was unanimously **resolved** for Cllr Varney to be appointed.

2/22 Apologies

All members of the Parish Council were present at the meeting.

3/22 May 2022 Election / Casual Vacancies

It was noted SSDC had not only received enough nominations for an actual poll to take place for Ashill Parish Council, on 5 May 2022, but had also not received enough nominations for the Parish Council to be quorate. Therefore a second nomination period had been run by SSDC between 13 May 2022 & 26 May 2022. This time enough nominations for Ashill to be able to form a Council had been received leaving a remaining four Casual Vacancies to be filled by co-option. Mr N Harvey & Mrs R Fry, who had registered an interest prior to this meeting, were welcomed & it was unanimously **resolved** for Mr Harvey & Mrs Fry to be appointed.
